- The balance of the TPP ("Balance Purchase Price") shall be paid in full by the Purchaser to the Assignee/Bank or to the Solicitors within ninety (90) days from the date of the auction sale by <u>RENTAS/BANK DRAFT/CASHIER'S ORDER</u> drawn in favour of AmBank (M) Berhad for the account (Abu Bakar Bin Shapiai and Siti Suziana Binti Mamat) and that there shall be no extension of the period so specified.
