- 7.5 The balance of the TPP ("Balance Purchase Price") shall be paid in full by the Purchaser to the Assignee/Bank or to the Solicitors within ninety (90) days from the date of the auction sale by <u>RENTAS/BANK DRAFT/CASHIER'S ORDER</u> drawn in favour of AmBank (M) Berhad for the account (Ponnayah A/L Ramasamy and Suppumah A/P Thavase) and that there shall be no extension of the period so specified.
